THE FOLLOWING ARE GUIDELINES FOR THE ORGANIZATION OF SYMPOSIA AND INVITED PAPER SESSIONS FOR MEETINGS OF THE ANIMAL BEHAVIOR SOCIETY.

- 1. An invited paper session is a group of theme-related papers offered by invitation. This should be distinguished from a symposium, which is a composite review by several authorities of the present state of our knowledge on a topic of general interest, and a discussion of the important frontiers to be crossed by future research. An invited paper session might stress recent studies by the contributors, whereas a symposium would be most unlikely to do so.
- 2. Proposals for invited paper sessions and symposia should describe completely the scope and organization of the undertaking. They should be submitted to the Program Officer as far in advance as possible, so that they can be acted upon by the Executive Committee. Normally only one or two symposia would be accepted for a given meeting, and they would be held at such a time as to minimize conflicting concurrent activities. Invited paper sessions should not normally exceed one-half day in length, and only very exceptional symposia should run longer than one day.
- Symposia should be organized in such a way as to stimulate thorough discussion among the contributors and with non-contributors in the audience.

A set of Guidelines for the Organization of Regional Meetings has been prepared by an Ad Hoc Committee on Regional Meetings, chaired by E. O. Price. They are available to prospective hosts of Regional Meetings from: D. G. Kleiman, ABS Secretary, National Zoological Park, Washington, D. C. 20008.

#### Minutes of the Animal Behavior Society Business Meeting, 13 June 1979, New Orleans, La.

- 1. President Dewsbury called the meeting to order at 1040 hours.
- 2. A motion to waive reading the minutes of the 1978 Business Meeting was passed. The minutes were accepted as published in the August 1978 Newsletter.
- 3. President Dewsbury thanked the local host, Terry Christenson, for such a well-organized meeting.
- 4. President Dewsbury introduced the new officers who will take office July 1, 1979 and thanked the outgoing officers for their efforts on behalf of the Society. Nominees for office in the 1979 elections were announced.
- 5. Secretary Kleiman summarized the annual reports of the Executive Committee and Committee Chairpersons and the major actions taken at the 1979 Executive Committee Meeting.
  - a) One proposed symposium was approved for the Animal Behavior Division (ABD) of the American Society of Zoologists (ASZ) meeting in Seattle in 1980: M. Beecher, organizer. "From Individual to Species Recognition: Theories and Mechanisms." The Executive Committee in future will formally approve all proposed symposia for ABD/ASZ.
  - b) Member-at-Large D. Dunham reported on the recommendations of the Ad Hoc Committee on Symposia. The Guidelines for Symposia will be finalized and published in the <u>Newsletter</u>. There will continue to be no financial support from ABS for symposia at Annual Meetings.
  - c) No symposia have been approved yet for the 1980 ABS Annual Meetings in Ft. Collins.
  - d) An Ad Hoc Committee was established to explore alternate timing for ABS Annual Meetings since the current meeting time conflicts with the beginning of the field season.
  - e) An Ad Hoc Committee was established to explore mechanisms for holding the number of papers submitted for Annual Meetings to the limit of 295. (The Committee later recommended, and the E.C. agreed, that all contributed papers at the 1980 ABS Annual Meeting will be limited to 12 minutes presentation and 3 minutes discussion.)
  - f) The Nominating Committee (the three Past-Presidents) each year will recommend three names to the Program Officer as potential keynote speakers for subsequent Annual Meetings.
  - g) There was still no host for the 1982 Annual Meeting.
  - h) Treasurer Terman reported that the Society was financially sound. He suggested that we recruit Ecological Society of America (ESA) members since ESA was no longer handling subscriptions for <u>Animal Behaviour</u>. He expressed concern over the drop in membership.
  - i) Editor Altmann reported that the submission rate to <u>Animal Behaviour</u> is rising again after a nadir in Spring 1978. Current acceptance rate is 40-50%. The Association for the Study of Animal Behaviour (ASAB) is not contributing \$1000/year to the U.S. editorial office, and the University of Chicago is also providing about \$1800/year support.
  - j) First President-Elect Barlow's motion that a By-Law change be proposed at the Business Meeting to give responsibility for the Allee Award Competition to the Second President-Elect since the First President-Elect will be preparing to assume the Presidency at the time of each Annual Meeting was passed by the E.C.
  - k) The Allee Award Competition will be kept to a maximum of 18 contestants by strict adherence to regulations. However, should there still be too many submissions, the best 18 submitted papers will be selected by a panel of judges chosen by the Chairperson of the Allee Award Committee.

- 1) Second President-Elect Price presented the recommendations of the Ad Hoc Regional Meeting Committee. The E.C. voted not to establish a standing Committee on Regional Meetings, but to provide to organizers of regional meetings the Guidelines for Regional Meetings prepared by Price's Committee, advertising space in the Newsletter and mailing labels at no cost. Treasurer Terman will return any monies held for regional meetings. Regional meetings will not be permitted to use the ABS name.
- m) The E.C. met with Mary Wiley, Business Manager of ASZ to discuss ABS/ASZ relations. Wiley indicated that members of the Animal Behavior Division (ABD) of ASZ do not receive a Newsletter nor do they vote for the Chairpersons of the Division (Chairpersons of the Division are the current officers of ABS). Also, the ABD is weak. The E.C. decided to meet with ASZ in 1980 and 1981 in Seattle and Dallas respectively, and in future to have a secondary annual meeting with ASZ as well as other organizations, whenever the geographic location and timing is compatible with the ABS annual meeting. (The E.C. later decided to have the Secretary and Wiley develop means to ensure that ABD members receive a Newsletter, not to change the election of the ABS officers, and to have the Parliamentarian Rebach draft new By-Laws for the ABD).
- n) The E.C. discussed methods for recruiting new members. We will recruit ASZ and ESA members by sending out membership application forms; also the <u>Newsletter</u> will print application forms, and application forms will be available at Annual Meetings and regional meetings. Membership Committee Chairperson Fentress will implement the publication of a membership list every three years.
- o) Ad Hoc Animal Care Committee Chairperson Halpin presented the final Committee report and the Proposed Guidelines on Animal Care. The E.C. moved to propose to the Business Meeting that the ABS By-Laws be changed to establish a standing Committee on Animal Care.
- p) President Dewsbury's new committee appointments were accepted. The E.C. accepted the offer of the American Psychological Association that ABS members get a reduced subscription rate (\$35) for the <u>Journal of Comparative and Physiological Psychology</u>.
- q) The Policy Committee, chaired by Candland, will be reviewing the consequences of having the President of ABS serve 2 instead of one year. The E.C. approved the motion that the use of the ABS name on items for sale will require the written approval of the President in consultation with the Treasurer and First President-Elect.
- r) Ad Hoc Committee on Resolutions Chairperson Burghardt presented his committee's recommendations. The Policy Committee will consider the report and establish a mechanism to implement proposed resolutions.
- s) Rebach, Chairperson of the Organization and By-Laws Committee, presented some cosmetic changes to the Constitution.
- t) Education Committee Chairperson DeGhett's\* report was read on progress in determining the costs and benefits to ABS of developing a slide library. The Committee was asked to revise the Graduate Programs in Animal Behavior brochure every four years and to prepare a new brochure for distribution to high school and college career counseling departments on careers in animal behavior.
- u) The E.C. met with AIBS Executive Director Arthur Gentile and President Paul Siegel to discuss the ABS/AIBS affiliation. AIBS functions were discussed and the E.C. moved to maintain the ABS relationship with AIBS and to have the ABS Representative to the AIBS Governing Board, Southwick, and the ABS Public Responsibilities Representative, Gauthreaux regularly summarize relevant AIBS activities for the E.C. and ABS membership.

- 6. President Dewsbury presented the proposed changes in the By-Laws.
  - a) MOTION: To alter the By-Laws such that the Chairperson of the Allee Award Committee is the Second President-Elect instead of the First President-Elect. PASSED.
  - b) MOTION: To alter the By-Laws such that the Executive Committee's duties do not include the selection of hosts for regional meetings. PASSED.
  - c) MOTION: To add to the By-Laws a new standing Animal Care Committee of 7 members with the following duties:
    - (i) shall maintain a file on federal and international legislation on animal welfare, endangered species, importation of research animals and related areas,
    - (ii) shall provide advice to members who seek counsel regarding treatment of animals in proposed research, and be available for consultation by the Editor of Animal Behaviour.
    - (iii) shall inform the membership of new legislation and other important events relevant to the care and treatment of research animals.

PASSED. There was discussion concerning whether the Committee will attend to legislation important for field researchers, whether there would be a committee budget, and whether ABS was going to adopt a set of Guidelines on Animal Care. The membership was informed that the Guidelines will be presented to ABS members for a vote, but that the Committee and Guidelines were independent of each other. Zuleyma Halpin is Chairperson of the Animal Care Committee.

- 7. Treasurer-Elect Graves announced that there was seed money for the Midwest and Southeast Regional Meetings. He indicated that members not receiving <u>Animal Behaviour</u> should write both to him and to the English publishers.
- 8. Membership Committee Chairperson Fentress reported on the drop in membership and encouraged members to recruit new members.
- 9. President-Elect Barlow reported that many people had avoided paying the Registration fee and that this not only hurts the ABS, but individual members as well, since ABS must cover deficits at Annual Meetings. This could reduce membership services.
- 10. Platt indicated that the next Midwest Regional Meeting might be held in Northern Michigan and was informed that he could obtain the Guidelines for Regional Meetings from Secretary Kleiman.
- 11. Member-at-Large Dunham reported that the Guidelines for Symposia will be published in the <u>Newsletter</u> as well as the recommendations of the ad hoc committee on regulating the number of contributed papers.
- 12. The meeting was adjourned at 1125 hours.
