REVIEWS, A NEW TYPE OF ARTICLE IN ANIMAL BEHAVIOUR

Chris Barnard, the European Editor of *Animal Behaviour*, and Bennet G. Galef, Jr., the North American Executive Editor, have agreed to start publishing Reviews in the journal. In anticipation of that development, the description of Reviews at the end of this message will soon be appearing in the Instructions to Authors published in the back of each issue of the journal. Please note that the procedure for submission of Reviews is different from that for submission of Articles and Commentaries. Academic Press, the publishers of *Animal Behaviour*, have agreed to provide extra pages for publication of Reviews, so their inclusion in the journal will not result in any fewer pages being devoted to publication of articles.

The introduction of Reviews is an exciting development in the life of the journal and one we hope will markedly increase its usefulness to you, the subscribers. Reviews should address fundamental issues relating to behaviour and provide new insights into the subject(s) they cover. Original interdisciplinary syntheses are especially welcome. Reviews should be no longer than 6,000 words (excluding references) and should include an abstract of up to 250 words. In the first instance, a preliminary outline of up to 600 words should be sent to the European or American Executive Editor according to the geographical location of the author. The decision as to whether to proceed to a full review then rests with the Executive Editors or invited advisers. Contributions submitted on this basis will be subjected to the same refereeing process as normal manuscripts.

NOMINATIONS SOLICITED FOR THE WILLIAM C. BROWN ANIMAL BEHAVIOR TEACHING AWARD

Thanks to the generosity of William C. Brown Publishers, the Animal Behavior Society solicits nominations for the William C. Brown Animal Behavior Teaching Award for 1998, to be awarded at the 1998 ABS meeting in Carbondale, Illinois. The awardee will receive a \$500 personal stipend and a grant of \$500 to enhance undergraduate instruction in animal behavior at the awardee's institution. Nominees for the award must show evidence of effective and innovative teaching and have a reputation among peers and students for excellence in undergraduate animal behavior instruction maintained over a number of years. Persons wishing to make a nomination must submit a one-page nomination letter and names, addresses and phone numbers of at least two additional references. Selection will be made by the ABS Education Committee; upon receipt of a nominating letter, the committee will solicit supporting materials such as course syllabi, student evaluation summaries, letters from students or peers, documentation of teaching awards and innovations, textual or laboratory materials, and other indicators of superior undergraduate teaching. Nominators and nominees must be members of the Animal Behavior Society; current officers and committee chairs of the Animal Behavior Society are not eligible for nomination. Nominations must be submitted by **March 15, 1998**, to: Dr. Michael Renner, Chair of the ABS Education Committee, Dept. of Psychology, West Chester University, West Chester, PA 19383.

JOHN T. EMLER JR
1908-1997

John T. Emler Jr. - gentle man, enthusiastic naturalist, teacher, scholar and longstanding professor at the University of Wisconsin - Madison, died November 8, 1997, at the age of 88 after a brief illness.

"Johnny" was born in Germantown, PA in 1908 to John T. Emler and Mary Jones, and grew up attending Germantown Friends School. He studied at Haverford College (BS 1931) and Cornell University (Ph.D. in Zoology/Ornithology, 1934). In 1934, after working as a park naturalist at Glacier National Park, he married Virginia Merritt, daughter of Cornell physics professor Ernest Merritt and Bertha Sutermeister Merritt.

He first went to Madison to work with Aldo Leopold and for the US Bureau of Biological Survey. Then, in 1935, he joined the biology department at the University of California at Davis, where he served as instructor of zoology until 1942 when he joined the Johns Hopkins School of Hygiene and Public Health on a wartime project on rat control in the city of Baltimore. After the war he returned to Madison as associate professor of zoology at the University of Wisconsin. Advanced to full professorship in 1947, he served as department chairman from 1950 to 1953 and continued as professor and senior zoologist until his retirement in 1974.

Dr. Emler was a pioneer in evolutionary studies of animal ecology and behavior, concentrating on field studies of birds and mammals in their natural habitats. He was a fellow of numerous professional societies and served as president of the American Ornithologists' Union, the Wilson Ornithological Society, and the Wisconsin Society for Ornithology. He was both a John Simon Guggenheim and Fulbright Fellow, and received the highest honor conferred in American ornithology, the Elliot Coues Award, in 1973. At the University, where he was fondly known as "Doc", he mentored 39 doctoral and 22 Master's students, many of whom are current leaders in their disciplines throughout the world. In his later years, the University established a scholarship fund in his name, to be awarded each year to a graduate student with outstanding potential for creativity in field research.

Beset with heart problems in 1965, he was obliged to go part time at the University. Nevertheless, he managed to continue his research studies, working as

a team with his wife "Jinny" in many parts of the world. He summarized his life in the following words: "I can look back over a rich and rewarding life in which I have visited all of the world's continents and many of its islands. How lucky can a guy get?"

He is survived by his wife Virginia and three sons. John Merritt Emler, senior biologist with the US Geological Survey in Seattle, WA., Stephen Thompson Emler, professor of behavioral ecology at Cornell University in Ithaca, NY, and James Woodruff Emler, Vice President for Exploratory Research at Connetics Corporation in Palo Alto CA. He has five grandchildren: Douglas Emler, an assistant professor of Zoology at the University of Montana, Katharine Emler of Boulder, CO, Owen Emler and Robyn Emler of Denver, CO, and Scott Emler of Seattle.

REQUEST FOR ETHOGRAMS

The Behavior and Husbandry Advisory Group (BHAG) of the American Zoo and Aquarium Association (AZA) requests ethograms for an Ethogram Repository.

For many zoo staff and affiliates wishing to initiate a behavioral study, particularly of a little-known or rare species, a bottleneck in the process is compiling an ethogram. Additionally, zoo staff find ethograms useful when adding a new species to their collection, designing appropriate enrichment and exhibits, and developing signs and educational material.

To facilitate the use of behavioral information in zoos, the Behavior and Husbandry Advisory Group of the American Zoo and Aquarium Association (AZA) is establishing a repository of ethograms. We have begun the process of collecting and compiling existing ethograms and would like your help. We are making a standing request of researchers in Animal Behavior to assist us in this effort by sending copies of published or unpublished ethograms they have developed and used in their studies. Author/s of the ethogram will be cited at the top of the first page. Ethograms will be stored and provided to AZA member institutions (with relevant citations) upon request.

At this time we are requesting only vertebrate behavior ethograms and those of cephalopods. Although it is optional, we would prefer that donors include the following information with their ethograms, unless it is part of a publication included with the ethogram: Species, author of the ethogram, location of the study, length of study period, sampling method, composition of the study group (i.e. single animal, single sex group, or mixed sex group), contact person for questions & any additional references you would recommend. We would also appreciate any suggestions the author has for modifications to the ethograms used in a study. Please send your hard copy or e-mail to the above contact.

XIII World Meeting of ISRA. The International Society for Research on Aggression (ISRA) is a society of scholars and researchers interested in the scientific study of violence and aggression. The society is both international and interdisciplinary and meets every other year on alternating continents. Currently there are over 300 members from 34 countries with specialties in psychology, psychiatry, physiology, sociology, anthropology, animal behavior, and pharmacology. The current president of ISRA is Rowell Huesmann of the University of Michigan and the Executive Secretary is Ed Donnerstein of the Univ. of California Santa Barbara. ISRA publishes a journal of research entitled *Aggressive Behavior* (edited by Ron Baenninger of Temple University) and the *ISRA Bulletin* edited by Roger Johnson (USA) and Kaj Bjorkqvist (Finland). From July 12-17, 1998, ISRA will celebrate its 25th anniversary with the XIII World Meeting. The conference will be held on the campus of Ramapo College of New Jersey, a 300 acre campus located in the suburban town of Mahwah, New Jersey, just 20 miles from New York City. 


